Andrew Fellows

Andrew is Director of Christian Heritage in Cambridge. He is eager to see believers align their thinking and outlook with the gospel. Before his current post, he served as a pastor of a church in Bradford, then at L'Abri Fellowship UK, and from 2011 to 2016 he was the Chairman of L'Abri International. Andrew is married to Helen and they have four children.

Mark Jones

Mark is a partner in a solicitors' firm. He specialises in employment law and has been involved in many ground breaking and high profile cases from the Employment Tribunal to the European Court of Human Rights, including the first successful Article 9 case against the UK. He is also the Chair of the LCF and a director/trustee of three other charities. He attends church in Surrey, leading a discipleship group and one of the youth ministries.

Trevor Stammers

Trevor is a Reader in Bioethics and Director of the Centre for Bioethics and Emerging Technologies at St Mary's University in London. His research interests are in the ethics of organ donation and in genetic manipulation. Before entering academia, Trevor was a GP for 27 years. He is married with three adult children and could have achieved none of the preceding without his wife Rachel.

Rev. Dr. Craig G. Bartholomew

Craig is the Director of the Kirby Laing Institute for Christian Ethics (KLICE) in Cambridge, having recently been Professor of Philosophy and Professor of Religion and Theology at Redeemer University College in Ancaster, Canada. He is also an Anglican priest and his academic background is in Old Testament studies and hermeneutics. He has edited and written many books, most recently (2017) Beyond the Modern Age: An Archaeology of Contemporary Culture.
